Bylaw # 2019-113

Being a Bylaw to approve fees for various services carried out by or under the jurisdiction of the Fire Department of the Corporation of the Municipality of Highlands East.

Whereas the Municipal Act, 2001, S.O. 2001, Chapter 25, S. 391 (1), as amended provides that a municipality may pass a by-law setting fees for certain services within the municipality;

And Whereas, the Council for the Corporation of the Municipality of Highlands East deems it desirable to adopt a Schedule of Fees for inspections and other services provided by the Fire Department of the Municipality in an effort to ensure that the resources of its Fire Department are used in an efficient and productive a manner as possible;

Now therefore the Council of the Municipality of Highlands East enacts as follows:

That this Bylaw applies to services provided by or under the jurisdiction of the Fire Department of the Corporation of the Municipality of Highlands East (hereinafter the "Fire Department") and set out in Schedule "A".

1. Where the Fire Department provides any emergency Response Service as listed in Schedule "A", the person(s) or corporation(s) receiving or obtaining the benefit of the Emergency Response Service shall pay to the municipality the applicable fee(s) listed in Schedule "A".
2. The Treasurer of the Municipality is hereby appointed and authorized to take all necessary procedures for the billing and collection of the said fees.
3. There shall be added to any fee thereof due, but unpaid, the sum of 1.25% on the unpaid balance on the day following the due date, and the first day of each calendar month thereafter.
4. Any payments for fees regarding Emergency Response Services not received by the Treasurer within 60 days of the invoicing date shall be added by the Treasurer to the tax roll of the property owner to be collected in the same manner as municipal taxes.
5. This Bylaw shall come into force and take effect upon the date of its passage.
6. If any section or part of this Bylaw is found to be illegal or beyond the power of the Municipal Council to enact, such section shall be deemed to be severable

10. That this Bylaw shall take effect upon final passing.

Fire Department Services Fees	
Service	Fee/Charge
Fire Incident Report/File Search	\$ 75.00 payable upon receipt of the report
Fire Inspections	\$ 75.00 payable before inspection commences
Burning Permit - Daytime	\$ 50.00 payable upon receipt of permit
Responses to all motor vehicle accidents, including Motor Vehicle Fires, motorized snow vehicles, all-terrain vehicles, on any road or trail.	Ministry of Transportation Rates applicable at time of call
Outdoor Burning Violation	Ministry of Transportation Rates and/or appropriate fine from the Open Air Burning Bylaw, applicable at time of call
Fire Investigation: (Cost Recovery)	Municipal and third party contractor fees involved with investigation
False Alarm Response	Ministry of Transportation Rates applicable at time of call for each alarm after the second alarm in a twelve (12) month period
